I, _____ (name of foster applicant) make the above statements and voluntarily enter into this agreement to provide a temporary home as a foster caregiver to any animals Husker Weim Rescue, Inc (referred to as HWR, Inc.) may temporarily place in my care.

*I agree to provide a HWR, Inc. representative access to all parts of my home and property for a home inspection before my application to foster is approved. *I understand that I may be required to provide foster care to my foster animal for an extended and indefinite period of time. *I agree that I am 21 years of age or older. *I understand that HWR, Inc. provides no guarantee as to the health of my foster animal and that my foster animal may have medical needs, socialization problems, and may not be housebroken. *I agree to provide my foster animal with veterinary care as authorized by HWR, Inc. I will not arrange to pay for any elective veterinary care for my foster animal without the express consent of an authorized HWR, Inc. representative. *I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event this happens, I will notify HWR, Inc. immediately. *I understand that I may only have my foster animal temporarily. *I agree that I am fostering this animal for HWR, Inc., and that I do not have any right of ownership over my foster animal. I further agree that HWR, Inc. rights in and to my foster animal are superior to mine. I also agree to provide a HWR, Inc. representative access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal. *I agree to immediately return any foster animal in my care to HWR, Inc. at the request of it's authorized representative at any time and for any reason. If HWR, Inc. is forced to undertake legal action to enforce this provision of the agreement, I agree to indemnify HWR, Inc. for all court costs and attorney fees connected with such an action. *If I am planning to move at any time during the period when I am housing a foster animal, I agree to contact HWR, Inc. prior to my move and provide HWR, Inc. with my new contact information. I understand that HWR, Inc. has the right to request the return of my foster animal based on my change of residence, and agree that I will surrender my foster animal and all supplies (provided by HWR, Inc.) to HWR, Inc. immediately upon request. *I understand that as long as I provide foster care to my foster animal to HWR, Inc. satisfaction, I will be given the first right of adoption of my foster animal, at such time as HWR, Inc. decides to place my foster animal for adoption. At that time of agreement, the decision to adopt is to be agreed in a one week period. *If at any point I can no longer, or do not want to continue to provide care and shelter for my foster animal, I agree to contact HWR, Inc. and arrange for the surrender and return of my foster animal back to HWR, Inc. *I will not transfer possession or custody of my foster animal to any other person at any time, except for temporary, short-term possession for the purpose of vet care, grooming, etc. *I agree to contact HWR, Inc. with any and all questions and concerns about my foster animal or the HWR, Inc. foster care program, as well as with updated contact information. *I agree that if I refuse or fail to comply with any provision of this agreement, HWR, Inc has the right to terminate this agreement and also has the right to the immediate surrender and return of my foster animal(s). I further consent to provide HWR, Inc. access to my premises if necessary to facilitate the return. *I agree that the opportunity

given to me to help rehabilitate my foster animal, as well as the chance of a potential future adoption, is of significant benefit to me, and serves as proper legal consideration in exchange for my agreement to the terms of this contract.

I have read this application and agreement in its entirety, and I agree that all statements and agreements contained in this document are made by me and are truthful, under penalty of perjury under the laws of the State of Nebraska.
